ONESKY GOT ITS START WORKING WITH STATE-RUN ORPHANAGES IN CHINA, TRANSFORMING YOUNG LIVES WITH INFANT NURTURE CARE AND EARLY LEARNING PROGRAMS DESIGNED ESPECIALLY FOR INSTITUTIONALIZED CHILDREN. TODAY, THIS WORK CONTINUES WITH A FOCUS ON SUPPORTING THE INCREASING NUMBERS OF CHILDREN WITH SPECIAL NEEDS LIVING IN ORPHANAGES. IN 2020, DUE TO THE PANDEMIC, MOST ORPHANAGES WERE ON COMPLETE LOCKDOWN FOR THE FIRST PART OF THE YEAR.
